# **Change-in-Terms Notice Expedited Funds Availability Policy**

On **July 1, 2025**, we are increasing the amount of funds that will be available when a check deposit is placed on hold. Below are the changes to your

Agreements and Disclosures – Funds Availability Policy Disclosure

- Other Check Deposits: The first \$275 (previously \$225) of other checks deposited will be available on the first business day after the day we receive the deposit.
- Longer Delays May Apply: If you deposit checks totaling more than \$6,725 (previously \$5,525) on any one day, you may experience a delay.
- Special Rules for New Accounts: The first \$6,725 (previously \$5,525) of a day's total deposits of cashier's, certified, teller's, traveler's, and federal, state and local government checks will be available on the first business day after the day we receive the deposit. The excess over \$6,725 (previously \$5,525) will be available on the seventh business day after the day of your deposit. If your deposit of these checks (other than a U.S. Treasury check) is not made in person with one of our employees, the first \$6,725 (previously \$5,525) will not be available until the second business day after the day of your deposit.
